### **AGREEMENT FOR SERVICES**

This Agreement for Services ("Agreement") is entered into and effective this 9th day of November, 2023 by and between SPRING MESA METROPOLITAN DISTRICT, a quasi-municipal corporation and political subdivision of the State of Colorado (the "District"), and THE CUTTING EDGE LANDSCAPING, INC., a Colorado corporation ("Contractor").


The work or services to be provided by the Contractor to the District are generally as follows: 1. tree fertilization and tree maintenance services, as further described in Exhibit A, attached hereto and incorporated herein (the "Work"). The Work shall be rendered in a timely manner or as specified in the description of the Work. The term of this Agreement shall run through the completion of the Work unless otherwise terminated by the District as provided herein. The total compensation due for the Work provided by Contractor shall be pursuant to Exhibit 2. A. Contractor shall submit to the District by the first of each month detailed invoices of the Work performed and direct costs presented for reimbursement. Work performed in excess of the compensation amount above shall only be performed upon written authorization of authorized District personnel or the District's Board of Directors. The Contractor is an independent contractor and nothing herein contained shall constitute or designate the Contractor as an employee or agent of the District. The District is concerned only with the results to be obtained. The District will not withhold any taxes or other amounts from any compensation paid to Contractor. The payment of any and all federal, state, and local taxes or other required withholdings shall be the sole responsibility of Contractor. Contractor is not entitled to Worker's Compensation benefits or unemployment insurance benefits. The Contractor shall indemnify, defend and hold harmless the District, its members, directors, 4. officials and employees from and against any and all claims, demands, suits, actions, judgments, losses, damages, injuries, penalties, costs, expenses (including attorney's fees) and liabilities to the extent they are alleged to arise from the intentional misconduct or negligent acts or omissions of the Contractor or Contractor's sub-contractors and/or employees. The obligations of this indemnification shall survive termination of this Agreement. Contractor shall carry insurance of the type and in the amounts as described in Exhibit B 5. hereto. Proof of such insurance coverage shall be presented to the District prior to the performance of the Work. Nothing herein shall be deemed a waiver of immunity under § 24-10-101, et seq., C.R.S. The District may terminate this Agreement not-for-cause, in whole or in part, by delivering 6. written notice of termination to Contractor specifying the extent and timing of such termination. The District shall pay Contractor for Work performed and materials actually provided to the District prior to such notice.

The Contractor shall be informed of and comply with all federal, state and local laws, 7. ordinances and regulations and any applicable rules and regulations of the District.

IN WITNESS WHEREOF, the parties have executed this Agreement on the date first above written.


